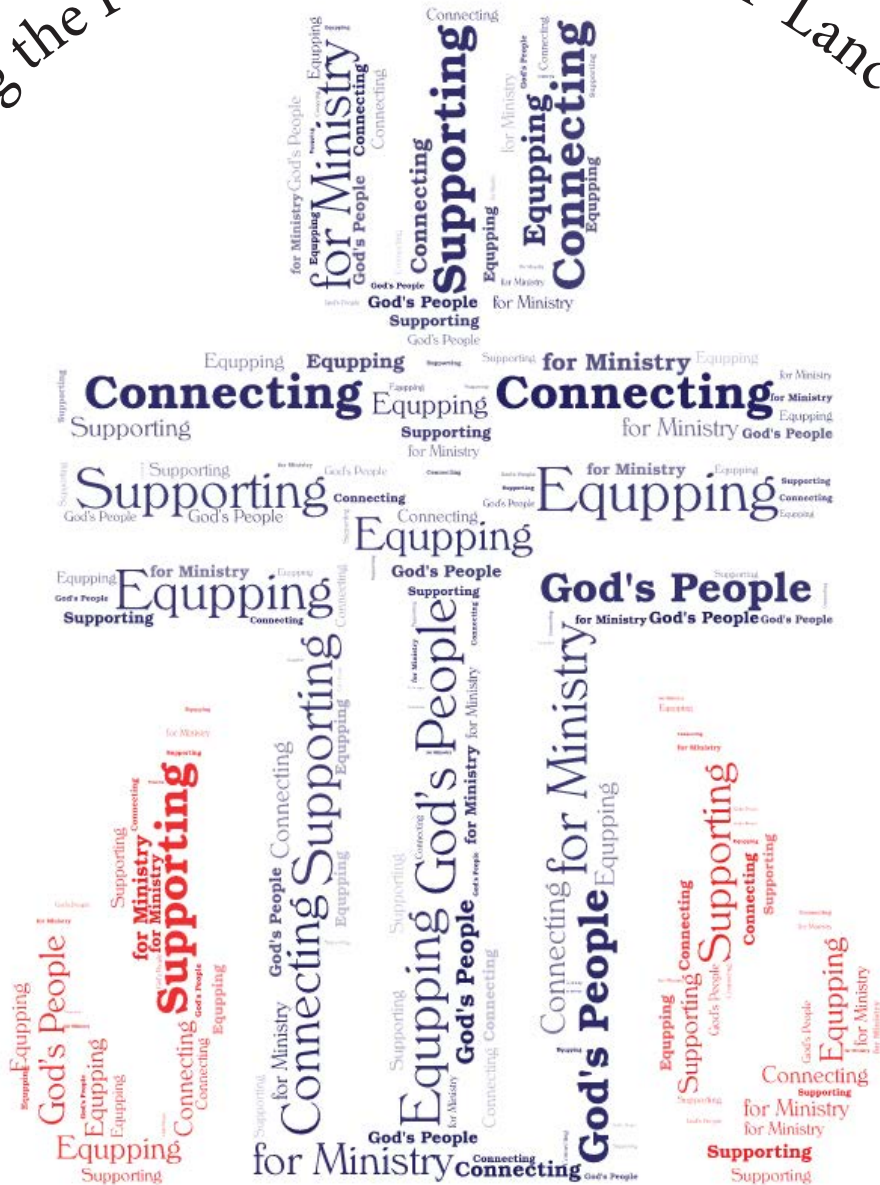

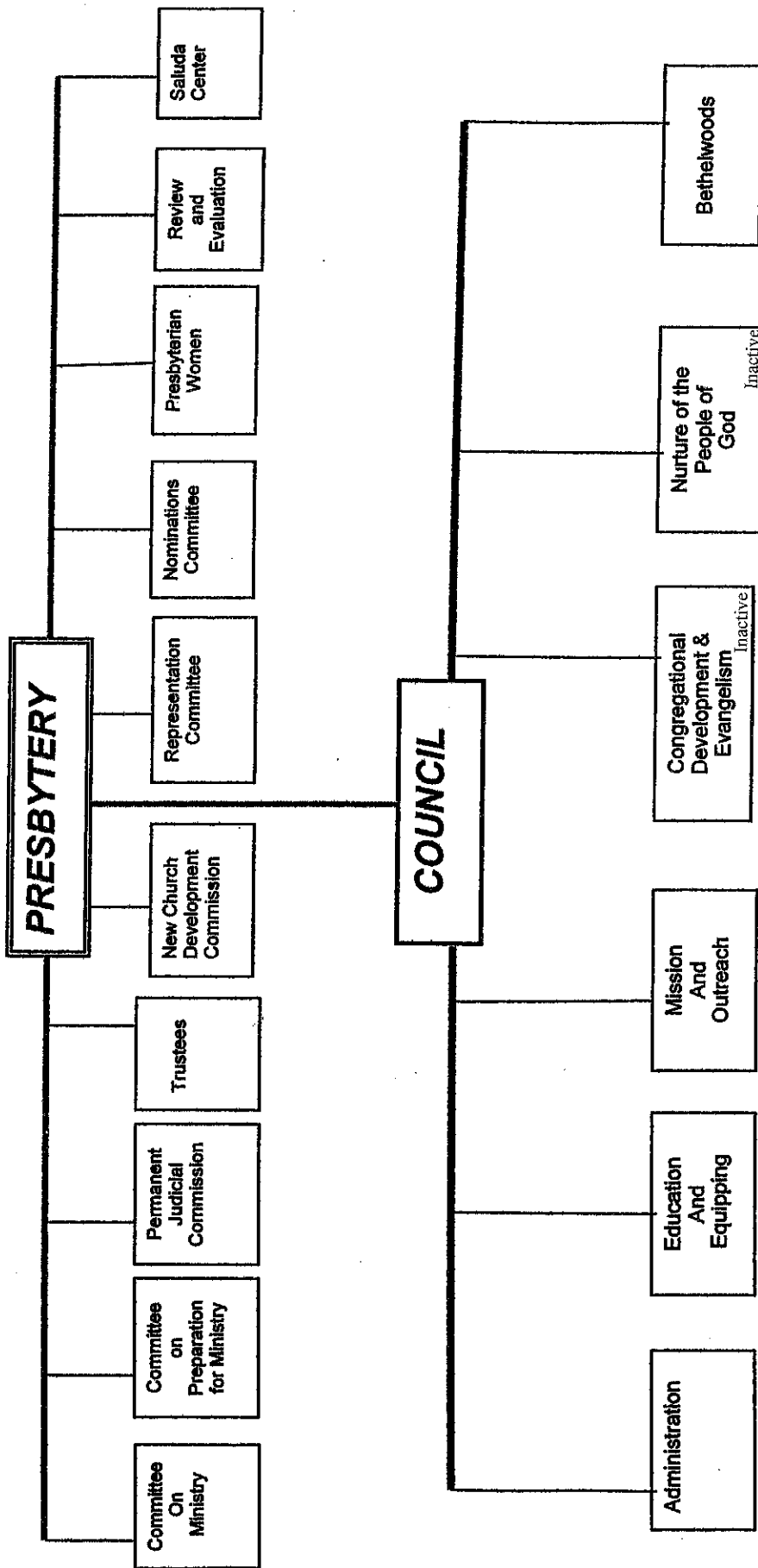

Coming from Charlotte:

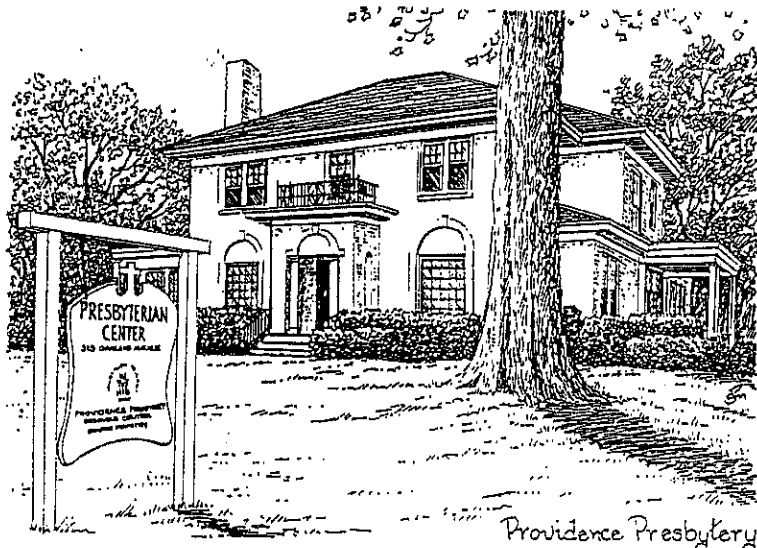
Take Exit 82 B - A (Hwy. 21-Rock Hill) off of I-77. Follow the sign for Hwy. 21 South - Rock Hill. This will put you on Cherry Road (Hwy. 21 South is the same as Cherry Road). There is a light as you come off the exit ramp (Cherry Road and Riverview Road). Count this stop light as the first traffic light. Travel down Cherry Road. You will go through 13 traffic lights (there is an emergency signal at the Fire Station - do not count this as a light). Turn left at the 13th light onto Oakland Avenue. It is 3.2 miles from the exit ramp to Oakland Avenue. To help recognize the Oakland Avenue intersection prior to being able to read the sign, there is a Citgo station on the left and a Walgreen store on the right. After you turn onto Oakland Avenue Winthrop University will be on the right.

After turning on Oakland Avenue, you will go through three more traffic lights. Turn right at the third traffic light onto Stewart Avenue. The Presbytery office is on the corner of Oakland Avenue and Stewart Avenue. The parking lot is on Stewart Avenue. It is .5 miles after turning on Oakland Avenue to the Presbytery Office.

Coming from Columbia

Take Exit 82 A-B- C (Hwy. 21-Rock Hill). Then take Exit 82 B- C (South Hwy. 21 - Rock Hill) Take Exit 82-B (South Hwy. 21 - Rock Hill). Bear right off the ramp. Go straight for 1/10 of a mile. McDonald's will be on your left. This will put you on Cherry Road (Hwy. 21 So. is the same as Cherry Road). There is a light as you come off the exit ramp (Cherry Road and Riverview Road). Count this stop light as the first traffic light. Travel down Cherry Road. You will go through 13 traffic lights (there is an emergency signal at the Fire Station - do not count this as a light). Turn left at the 13th light onto Oakland Avenue. It is 3.2 miles from the exit ramp to Oakland Avenue. To help recognize the Oakland Avenue intersection prior to being able to read the sign, there is a Citgo station on the left and a Walgreen store on the right. 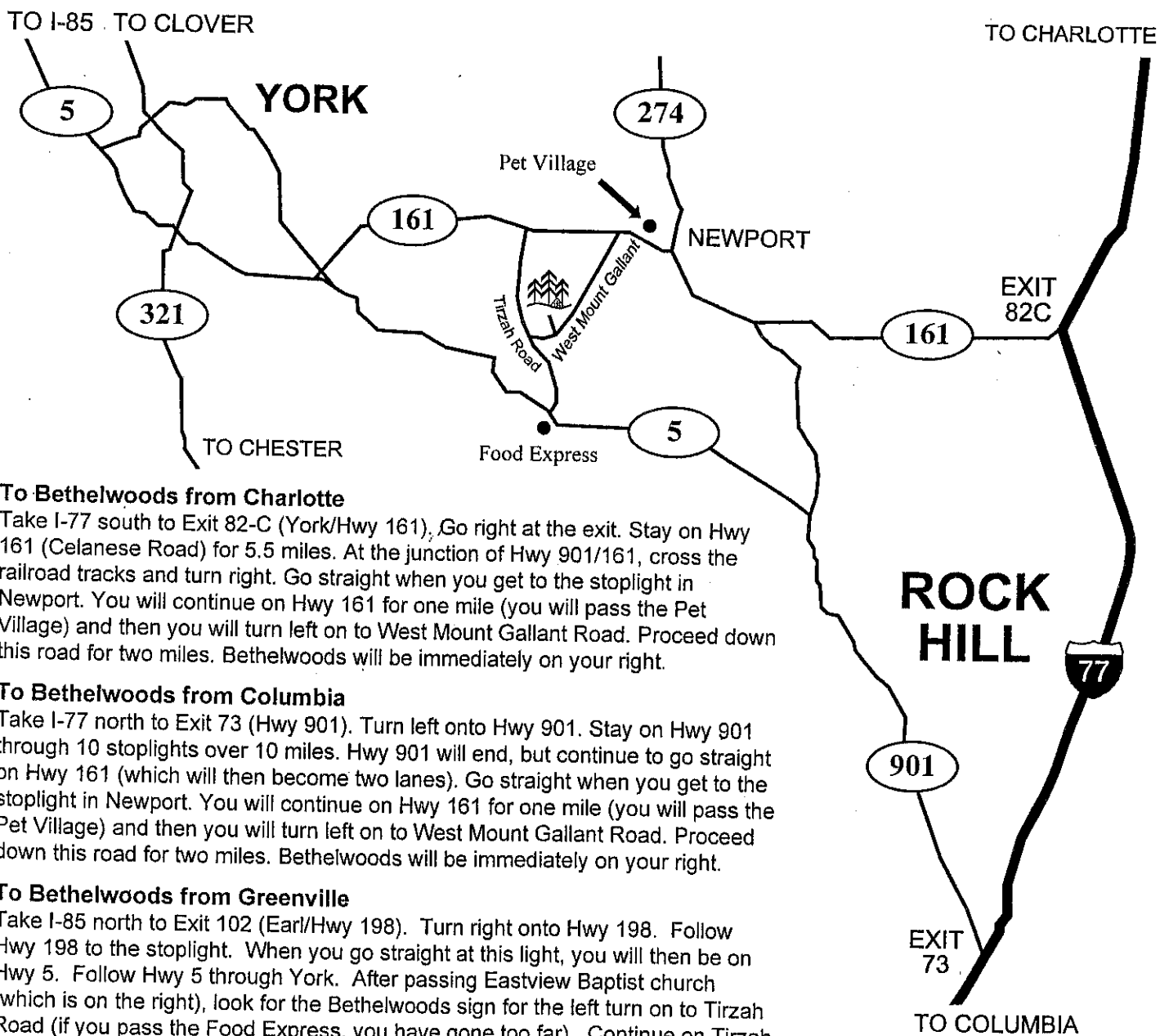

To Bethelwoods from Charlotte

Take I-77 south to Exit 82-C (York/Hwy 161). Go right at the exit. Stay on Hwy 161 (Celanese Road) for 5.5 miles. At the junction of Hwy 901/161, cross the railroad tracks and turn right. Go straight when you get to the stoplight in Newport. You will continue on Hwy 161 for one mile (you will pass the Pet Village) and then you will turn left on to West Mount Gallant Road. Proceed down this road for two miles. Bethelwoods will be immediately on your right.

To Bethelwoods from Columbia

Take I-77 north to Exit 73 (Hwy 901). Turn left onto Hwy 901. Stay on Hwy 901 through 10 stoplights over 10 miles. Hwy 901 will end, but continue to go straight on Hwy 161 (which will then become two lanes). Go straight when you get to the stoplight in Newport. You will continue on Hwy 161 for one mile (you will pass the Pet Village) and then you will turn left on to West Mount Gallant Road. Proceed down this road for two miles. Bethelwoods will be immediately on your right.

To Bethelwoods from Greenville

Take I-85 north to Exit 102 (Earl/Hwy 198). Turn right onto Hwy 198. Follow Hwy 198 to the stoplight. When you go straight at this light, you will then be on Hwy 5. Follow Hwy 5 through York. After passing Eastview Baptist church (which is on the right), look for the Bethelwoods sign for the left turn on to Tirzah Road (if you pass the Food Express, you have gone too far). Continue on Tirzah Road until it intersects with West Mt. Gallant Road at a stop sign. Turn right onto West Mt. Gallant Road. Bethelwoods will be immediately on your left.

HONORARIA FOR SUPPLY TEACHING ELDERS

A Suggested Policy for Churches of Providence Presbytery

The Presbytery office has been asked a number of times to provide the information on what amount the **Honorarium** should be when a teaching elder supplies the pulpit on a Sunday, when the pastor is away or when the church is vacant. The following is a suggested amount (remember - the church can pay what it chooses!):

I. The Amount of the Honorarium:

- A. Churches under 50 members are encouraged to pay a minimum honorarium of not less than \$75, which should be supplemented by an additional mileage reimbursement, if the supply teaching elder must travel more than 50 miles round trip to the church. (Current IRS mileage reimbursement rate is 53.54 per mile.) The Salary Studies Committee of Providence Presbytery has adopted the IRS rate.
- B. Churches between 50 and 200 members should provide an honorarium of not less than \$100 for one service and \$125 if there are two services. Same recommendation concerning mileage.
- C. Churches between 200 and 500 members should provide an honorarium of not less than \$125 for one service and \$150 if there are two services. Same recommendation concerning mileage.
- D. Churches over 500 members should provide an honorarium of not less than \$150 for one service and \$175 if there are two services. Same recommendation concerning mileage.

II. To Whom Do We Offer Honoraria?

The general guideline suggested by Providence Presbytery is that an honorarium be provided to any teaching elder filling your pulpit on any occasion when your teaching elder is not preaching and/or for the convenience of the church or teaching elder. An exception is when a teaching elder (or lay speaker) is representing an institution, program, or agency of the church whose cause is being presented or promoted and whose presence has been requested by the agency, institution, or cause.

Example: If your teaching elder is on vacation and you invite the president of Presbyterian College or a member of the Presbytery staff to fill the pulpit, an honorarium is expected. If the college requests the opportunity for a representative to be heard by your congregation in behalf of the college, no honorarium would be expected.
